Mayor Johnson called the meeting to order with the Pledge of Allegiance at 7:30 p.m. in the City of Northville Municipal Building, City Council Chambers, 215 W. Main Street, Northville, Michigan, 48167.

PRESENTATIONS

A. Citizens Comments

Larry Parks, 632 N. Center Street, spoke of a recent letter in the Northville Record that included negative comments pertaining to the recent Rib Fest event. Parks spoke of his support of this event, the history of Ford Field being donated to the City for park and event use, and the absurdity of not considering using Ford Field for events. He hoped that City Council would consider approving any future request for the Rib Fest event.

Parks also voiced appreciation to the Mayor for his dedication in serving the City for 28 years as Mayor. While he did not always agree, Parks noted that the Mayor has made tough decisions, which have led to a viable and financially-sound City.

NEW BUSINESS

A. Contract Award – E. Main Street Sewer Lining Project

In December 2014, a small portion of an existing 12 inch clay sanitary sewer line collapsed under E. Main Street just east of Griswold Street. A repair was quickly made on this sanitary sewer pipe, and the roadway was restored before the asphalt plants were closed for the season. In making these repairs, it was noticed that the top of this segment of pipe, which runs between Griswold and E. Cady Street, was heavily fractured suggesting that this segment of pipe could again collapse.

On May 4, 2015, City Council approved a change order to an existing professional services contract with Rowe Professional Services Company to design and assist the City in bidding out a pipe lining project for this segment of sewer pipe under E. Main Street. On October 13, 2015, the City accepted bids for this pipe lining project as follows:

Corby Energy Services, Inc. \$24,943.51 LiquiForce \$32,064.08

Because this work will not require excavation to take place on E. Main Street, this work may still be accomplished this construction season. Though some detouring of traffic will take place on this project, all work will take place inside or above existing manholes in the roadway under a permit from Wayne County Department of Public Services. It is expected that the work on this project should not take longer than three weeks to complete.

Rowe Professional Services has checked the bid and has worked with Corby Energy Services, Inc. in the past. Rowe is recommending Corby for this project. The City Attorney reviewed the contract documents for this project and approved them for City use. The contractor is able to obtain the insurance requirements approved for this project by the Michigan Municipal Risk Management Authority. City Council approved a budget of \$100,000 for this project in the proposed FY2016 budget. The amount submitted by Corby Energy Services, Inc. is well below this budgeted amount.

Motion Darga, seconded by McKindles to approve and award a contract to Corby Energy Services, Inc. in the amount of \$24,943.51 for the E. Main Street Sewer Lining Project. Further, the Public Works Director is authorized to sign this contract on behalf of the City. Motion carried unanimously.

MAYOR AND COUNCIL COMMUNICATIONS
